## NOTICE OF ANNUAL MEETING OF SHAREHOLDERS

**Notice is hereby given that the annual meeting of shareholders (the "Meeting") of Tecsyst Inc. (the "Company") will be held** at 11:00 a.m. on September 4, 2025. As last year, we will hold our Meeting in a virtual format, which will be conducted via live audio webcast supported by visual aids. **Shareholders will be able to participate online by visiting <https://meetnow.global/MC5QUCC>.** At the Meeting, you will have the opportunity to ask questions and vote on all the items to be considered. The Meeting will have the following purposes:

1. Receiving the financial statements of the Company for the financial year ended April 30, 2025 and the report of the auditors thereon;
2. Electing the directors;
3. Appointing the auditors and authorizing the directors to fix their remuneration;
4. Transacting such other business as may properly be brought before the Meeting or any adjournment thereof.

We are making the management information circular available online instead of mailing it to you, according to a set of rules developed by the Canadian Securities Administrators called Notice-and-access. Notice-and-access is a set of rules that allows issuers to post electronic versions of proxy-related materials online, via SEDAR+ ([www.sedarplus.ca](http://www.sedarplus.ca)) and one other website, rather than mailing paper copies of such materials to shareholders. Under notice-and-access, shareholders still receive a proxy form or voting instruction form enabling them to vote at the Meeting. However, instead of paper copies of the meeting materials, shareholders receive this notice which contains information on how they may access the meeting materials online and how to request paper copies of such documents.


